5 Documentation required pursuant to Article 11 of the Law on Mines and Minerals No.03/L-163,

Any proposed change of a Significant Owner of a Licensee or Permit Holder shall be subject to approval by the ICMM.

5.1. A copy of the concerned License and/or Permit, the proposed Transfer of Control agreement and all other material documentation related thereto;

5.2. A statement from the Licensee or Permit Holder setting forth the reasons for the Transfer of Control;

5.3. Information demonstrating that the New Licensee or Permit Holder would be eligible, under the present law, to receive such License or Permit if such Transferee were to apply for such a License or Permit;

a) Certificate of Business Registration with new name of the Owner

b) Certificate that he is not under Investigations by the Municipal Court

c) Decision by the Board of the Company by which it is changed the Licensee or Permit Holder

5.4. A written commitment by the proposed New Licensee to accept and discharge of all remaining obligations of the current Licensee or Permit Holder - whether arising under the License, the Permit, the present law or any other element of the Law of Kosovo - as of the effective date of the Transfer.

5.5. On an application for approval as required by article 11, the ICMM may require the submission of such information as the ICMM may reasonably deem necessary
